### National Single Window - Change of Reporting Formalities in German Ports

Dear Captain,

The change of the reporting formalities (start date 27.05.2015) for your vessel bound for a port in Germany occurs changes in the your work flow on board.

The background for the official change is the regulation 2010/65 of the European Community which requires some more data from your vessel.

In the future you will receive a **VISIT-ID** (one for each call in a German port) or a **TRANSIT-ID** if you intend to transit through the Kielcanal without departing from or calling a German port.

For the fulfillment of the new requirements we will support you with an outstanding assitance as follows:

- 1. Use of our tailor-made software EU-NOAD (EUropean Notification Of Arrival and Departure) or
- 2. Use of our tailor-made EU-NOAD Excel-Workbook.
- To 1. To simplify the formalities we are offering the new software called **EU-NOAD** which could be used at this moment for the call in a port/Kielcanal transit in Germany. In due course it will be updated for the use of the notification of your vessel in other ports in the European Community as well. The advantages are:
- Free of charge installation on PC and Laptop,
- Facilities to arrange im- and export to already existing Excel-sheets in use on board (für several reporting classes),
- Preselection of several details to reduce the work (ships type, Dangerous Goods etc.),
- Encryption of the data on board before sending process starts to meet the utmost data protection,
- Reduction of communication costs by minimized size of the attachment to be sent by email,
- Download of the software, the installation guide and the handbook by the links: www.eunoad.com, www.bsmd.de or on the webseite of your agency.

  - In addition to the notification for the ports in Germany the manufacturer of the software "Herberg Engineering" offers other (chargeable) modules to notify your vessel in the ports of the USA (e-NOA/D) and in Singapore (EPAN).
- To 2. If it is impossible for you to use the software for the notification we provide the attached EU-NOAD Excel-workbook (also designed by Master Mariners) to help you meeting the reporting requirements:
- Comprehensive set of all required data for the ports in Germany,
- Facilities to arrange im- and export to already existing Excel-sheets in use on board.

For every report sent via the EU-NOAD software or the EU-NOAD Excel-workbook you will receive a receipt. After the successful transmission to the state-owned "National Single Window" you will also receive a receipt containing the VISIT-ID or TRANSIT-ID. If errors in the notification occur you will receive a "violation list" to revise the errors. If we detect a missing information you will receive a message to add the required data. Your agent will be updated accordingly.
